AND DELIVERY OF 462 BAGS HYBRID CORN SEEDS**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last September 17, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 462 bags Hybrid Corn Seeds under the Corn Program;

WHEREAS, an opening of bids was conducted last October 8, 2019 at the DA Conference Room as scheduled;

WHEREAS, there was one (1) bidder that responded to the invitation, namely: Jedeco Trading Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that Jedeco Trading Corp. passed the eligibility requirements;

WHEREAS, upon evaluation of the submitted proposal conducted by the BAC members, it was found out that Jedeco Trading Corp. passed the eligibility and technical requirements and is considered the Single Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that Jedeco Trading Corp.'s bid offer is considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Supply and Delivery of 462 bags Hybrid Corn Seeds to Jedeco Trading Corp. as the bid is considered the Single Calculated and Responsive Bid;
