**RESOLUTION RECOMMENDING THE AWARD FOR (F3) PROCUREMENT FOR THE SUPPLY,  
DELIVERY AND INSTALLATION OF MULTI-PASS RICE MILL**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last September 17, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply, Delivery and Installation of Multi-pass Rice Mill under the Rice Program;

WHEREAS, an opening of bids was conducted last October 8, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Endutrac Marketing and Agricomponent Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Endutrac Marketing's bid offer is considered the Lowest Calculated Bid;


WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that Endutrac Marketing's bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply, Delivery and Installation of Multi-pass Rice Mill to Endutrac Marketing as the bid is considered the Lowest Calculated and Responsive Bid;
