**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE
LABOR AND MATERIALS FOR THE CONSTRUCTION OF WAREHOUSE AT BUTUAN CITY**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 15, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Labor And Materials For The Construction Of Warehouse At Butuan City under the Rice Program;

WHEREAS, an opening of bids was conducted last December 6, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were four (4) bidders that responded to the invitation, namely: LGTD CONSTRUCTION & DEVELOPMENT, POLIRAN BUILDERS CORP., C&R CONSTRUCTION & SUPPLY AND NAHARO BUILDERS;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that LGTD CONSTRUCTION & DEVELOPMENTS' bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that LGTD CONSTRUCTION & DEVELOPMENT'S bid offer is considered the Lowest Calculated and Responsive Bid;

WHEREAS, as per Circular No. 2019-1 dated January 3, 2019 guidelines for the release of funds for the first quarter of FY 2019 was circulated in lieu for the pending approval of GAA 2019;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Labor And Materials For The Construction Of Warehouse At Butuan City to LGTD CONSTRUCTION & DEVELOPMENT as the bid is considered the Lowest Calculated and Responsive Bid;


