A RESOLUTION DECLARING THE WINNING BIDDER FOR (A16) THE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF 2,000 BAGS GM HYBRID CORN SEEDS (YELLOW)

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 30, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 2,000 bags GM Hybrid Corn Seeds (Yellow) under the Corn Program;

WHEREAS, an opening of bids was conducted last November 20, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: MIRACLE HYBRID CORN SEEDS, RJR AGRO INDUSTRIAL ENTERPRISES and ASIAN HYBRID SEED TECHNOLOGIES;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that ASIAN HYBRID SEED TECHNOLOGIES' bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that ASIAN HYBRID SEED TECHNOLOGIES' bid offer is considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the procurement for the Supply and Delivery of 2,000 bags GM Hybrid Corn Seeds (Yellow) to ASIAN HYBRID SEED TECHNOLOGIES as the bid is considered the Lowest Calculated and Responsive Bid;


