



**A RESOLUTION DECLARING THE WINNING BIDDER FOR (A3.4) PROCUREMENT FOR THE SUPPLY AND DELIVERY OF HYBRID RICE SEEDS LOT 4- 240 BAGS M50**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last October 30, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Hybrid Rice Seeds Lot 4- 240 bags M50 under the Rice Program;

WHEREAS, an opening of bids was conducted last November 20, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Jedeco Trading Corp. and Long Ping Tropical Rice Devt. Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only Jedeco Trading Corp. passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Jedeco Trading Corp.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that Jedeco Trading Corp.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Hybrid Rice Seeds Lot 4- 240 bags M50 to Jedeco Trading Corp. as the bid is considered the Lowest Calculated and Responsive Bid;


