WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that ALL CERTIFIED EQPT TRADING CORP.'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that ALL CERTIFIED EQPT TRADING CORP.'S bid offer is considered the Lowest Calculated and Responsive Bid;




