WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that MEGAMIGHT ENTERPRISES passed the eligibility and technical requirements;


WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that MEGAMIGHT ENTERPRISES' bid offer is considered the Single Calculated Bid;






