WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) for Wet Season Lot 3- 1,500 bags under the Rice Program;

WHEREAS, an opening of bids was conducted last February 21, 2019 at the DA Conference Room as scheduled;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that OJM SEED PRODUCER AND AGRICULTURAL SERVICES passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that OJM SEED PRODUCER AND AGRICULTURAL SERVICES' bid offer is considered the Single Calculated Bid;






