WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) for Wet Season Lot 2- 4,800 bags under the Rice Program;

WHEREAS, an opening of bids was conducted last February 21, 2019 at the DA Conference Room as scheduled;

WHEREAS, there was one (1) bidder that responded to the invitation, namely: BAYUGAN SEEDS CENTER;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that BAYUGAN SEEDS CENTER passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that BAYUGAN SEEDS CENTER'S bid offer is considered the Single Calculated Bid;


WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that BAYUGAN SEEDS CENTER'S bid offer is considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) for Wet Season Lot 2- 4,800 bags to BAYUGAN SEEDS CENTER as the bid is considered the Single Calculated and Responsive Bid;


