WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Various Hybrid Rice Seeds (Certified) for Wet Season Lot 4- 500 bags M50 under the Rice Program;

WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that JEDECO TRADING CORP.'S bid offer is considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Various Hybrid Rice Seeds (Certified) for Wet Season Lot 4 - 500 bags M50 to JEDECO TRADING CORP. as the bid is considered the Single Calculated and Responsive Bid;






