WHEREAS, an opening of bids was conducted last December 6, 2018 at the DA Conference Room as scheduled;

WHEREAS, there was one (1) bidder that responded to the invitation, namely: MINDANAO ISLAND OILS;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that MINDANAO ISLAND OILS passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that MINDANAO ISLAND OILS' bid offer is considered the Single Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that MINDANAO ISLAND OILS' bid offer is considered the Single Calculated and Responsive Bid;

WHEREAS, as per Circular No. 2019-1 dated January 3, 2019 guidelines for the release of funds for the first quarter of FY 2019 was circulated in lieu for the pending approval of GAA 2019;




