WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that JGDM CONSTRUCTION'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that JGDM CONSTRUCTION'S bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement of Labor and Materials for the Construction of Kagbaya Diversion Dam to JGDM CONSTRUCTION as the bid is considered the Lowest Calculated and Responsive Bid;
