WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of Quimayong Diversion Dam under the Rice Program;

WHEREAS, an opening of bids was conducted last February 21, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: JGDM CONSTRUCTION and LGTD CONSTRUCTION & DEVELOPMENT;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only JGDM CONSTRUCTION passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that JGDM CONSTRUCTION'S bid offer is considered the Lowest Calculated Bid;



Monteagudo to award the Procurement of Labor and Materials for the Construction of Quimayong Diversion Dam to JGDM CONSTRUCTION as the bid is considered the Lowest Calculated and Responsive Bid;
