**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE (U26.1) PROCUREMENT FOR THE SUPPLY AND DELIVERY OF INBRED RICE SEEDS (CERTIFIED) FOR WET SEASON LOT 1- 2,000 BAGS**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) for Wet Season Lot 1- 2,000 bags under the Rice Program;

WHEREAS, an opening of bids was conducted last February 21, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: DOSEPCO and BUSEPCO;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that DOSEPCO'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that DOSEPCO'S bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) for Wet Season Lot 1- 2,000 bags to DOSEPCO as the bid is considered the Lowest Calculated and Responsive Bid;


