WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that EUNIC'S MARKEING'S bid offer is considered the Lowest Calculated Bid for Lot 1 and DAVAO TECHNOCRAFT for Lot 2;







