WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Various Hybrid Rice Seeds (Certified) for Dry Season Lot 1- 350 bags M78 under the Rice Program;

WHEREAS, an opening of bids was conducted last February 21, 2019 at the DA Conference Room as scheduled;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that Long Ping Tropical Rice Devt. Inc. passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Long Ping Tropical Rice Devt. Inc.'s bid offer is considered the Single Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that Long Ping Tropical Rice Devt. Inc.'s bid offer is considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Various Hybrid Rice Seeds (Certified) for Dry Season Lot 1- 350 bags M78 to Long Ping Tropical Rice Devt. Inc. as the bid is considered the Single Calculated and Responsive Bid;

RESOLVED, this 13<sup>th</sup> day of March at Butuan City, Philippines.






