WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that SUKI TRADING'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon post-qualification and deliberation conducted by the BAC members, it was found out that SUKI TRADING'S bid offer is considered the Lowest Calculated and Responsive Bid;


