WHEREAS, an opening of bids was conducted last November 20, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Cover and Pages Corp. and Legacy Sales and Printing Press, Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Cover and Pages Corp.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that Cover and Pages Corp.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Printing and Supply of IEC Materials to Cover and Pages Corp. as the bid is considered the Lowest Calculated and Responsive Bid;




