WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Supply and Delivery of 220 units Heavy Duty Plastic Pallet under the High Value Commercial Development Program;

WHEREAS, an opening of bids was conducted last December 09, 2019 at the DA Conference Room as scheduled;

WHEREAS, there was only one (1) bidder that responded to the invitation namely, First Pinnacle Trading Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found that First Pinnacle Trading Corporation passed the eligibility and technical requirements;



WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found that First Pinnacle Trading Corporation is considered the Single Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Supply and Delivery of 220 units Heavy Duty Plastic Pallet to First Pinnacle Trading Corporation as its bid is considered the Single Lowest Calculated and Responsive Bid.
