WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found that Supertrade Machinery Global Inc. is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Supply and Delivery of 10 units Multi Cultivator to Supertrade Machinery Global Inc. as its bid is considered the Lowest Calculated and Responsive Bid.
