A RESOLUTION RECOMMENDING THE AWARD FOR (A13) PROCUREMENT FOR THE SUPPLY AND DELIVERY OF BREEDER STOCKS

Resolution No. 04-2020
Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites www.da.caraga.gov.ph and www.philgeps.net last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Breeder Stocks under the Livestock Program grouped into 3 lots;

Lot 1 - 33 head PS/Gilt
Lot 2 - 50 head Cattle
Lot 3 - 50 head Dairy Goat

WHEREAS, an opening of bids was conducted last December 09, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were four (4) bidders that responded to the invitation, namely: Tommys Hog and Cattle, Julimons Enterprises, BMA Livestock Dealer and Wellisa Farm Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, the following were the findings:

- Lot 1 - Tommys Hog and Cattle's bid is the Lowest Calculated Bid, but is disqualified due to non-compliance of BAI Swine Breeder Farm Accreditation requirement.
- Lots 2 and 3 - Tommys Hog and Cattle's bid is considered the Lowest Calculated Bid both for Lots 2 and 3 was found out to have complied with the technical requirements.

WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found out that Wellisa Farms bid is considered the Lowest Calculated and Responsive Bid for Lot 1 while Tommys Hog and Cattle is also considered the Lowest Calculated and Responsive Bid for Lots 2 and 3;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Breeder Stocks to Wellisa Farms for Lot 1, while Tommys Hog and Cattle for Lots 2 and 3, as their bids were considered the Lowest Calculated and Responsive Bid.


