A RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF VARIOUS PRODUCTION EQUIPMENT (A15)

Resolution No. 05-2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites www.da.caraga.gov.ph and www.philgeps.net last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery Various Production Equipment under the High Value Development Program grouped into 5 lots;

WHEREAS, an opening of bids was conducted last December 09, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: Suki Trading Corporation, Sentinel Plastic Manufacturing Corporation and J-777 Agri Marketing Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, the following were the findings:

- Lot 1 - No bids received
- Lots 3 and 4 - J-777 Agri Marketing Corporation's bid was found to have complied with the technical Requirements and is considered the Single Lowest Calculated Bid both for Lots 3 and 4.
- Lot 5 - Suki Trading Corporation submitted bid but was declared disqualified due to non compliance with the technical requirements.
- Lot 6 - Sentinel Plastic Manufacturing Corporation' was found to have complied with the technical requirements and is considered the Lowest Calculated and Responsive Bid .

WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found out that J-777 Agri Marketing Corporation's bid is considered the Lowest Calculated and Responsive Bid for Lot 3 and 4 while Sentinel Plastic Manufacturing Corporation is also considered the Lowest Calculated and Responsive Bid for Lot 6;

FURTHER, the BAC recommends that Lots 1 (7 units Power Sprayer) and Lot 5 (14 units Moisture Meter) be rebid.


