**A RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF
VARIOUS EQUIPMENT (A19)**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites www.da.caraga.gov.ph and www.philgeps.net last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement on the Supply and Delivery of Various Equipment under the Organic Agriculture Program grouped into 2 lots;

Lot 1 - 8 units Shredder
Lot 2 - 5 units Vacuum Pack Sealer

WHEREAS, an opening of bids was conducted last December 09, 2019 at the DA Conference Room as scheduled;

WHEREAS, there was only one (1) bidder that responded to the invitation, namely: Suki Trading Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found that Suki Trading Corporation passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, the following were the findings:

Lot 1 - No bid received
Lot 2 - Suki Trading Corporation's bid is considered the Single Lowest Calculated Bid.

WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found that Suki Trading Corporation's bid is considered the Single Lowest Calculated and Responsive Bid for Lot 2 ;

FURTHER, the BAC recommend that Lot 1 (8 units Shredder) be rebid.
