**RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF FOUR-WHEEL DRIVE (4WD) FARM TRACTOR (90-95 Hp) (A2)**  
Resolution No. 34, 2020

WHEREAS, the Department of Agriculture Regional - Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of 7 Units Four wheel (4WD) Farm Tractor under the Corn Program;

WHEREAS, an opening of bids was conducted last December 09, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were five (5) bidders that responded to the invitation, namely: Ford Tractor Philippines, Filholland Corporation, All Certified Equipment Trading Corporation, Super Trade Machinery Global, Inc. and Agri Component Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal by the TWG and based on the deliberation conducted by the BAC members, the following findings and decisions were made:

*Ford Tractor Philippines' bid was declared disqualified due to alteration on the Bid Form.  
Filholland Corporation was also disqualified due to alteration on the Bid Form and Omnibus Sworn Statement.  
All Certified Equipment Trading Corporation was likewise disqualified due to alteration on the Omnibus Sworn Statement.*

WHEREAS, Supertrade Machinery Global Incorporated's bid, being the next lowest calculated bid was considered and it was found out the said bidder had complied with all the requirements subject to post qualification;

WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found that the bid of Supertrade Machinery Global Incorporated is considered the Lowest Calculated and Responsive bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the supply and delivery of 7 units Four-wheel drive (4WD) Farm Tractor (90-95hp) to Supertrade Machinery Global Incorporated, as its bid is considered the Lowest Calculated and Responsive Bid.
