A RESOLUTION RECOMMENDING THE AWARD FOR (A2.1) PROCUREMENT FOR THE SUPPLY AND DELIVERY OF DRUGS AND BIOLOGICS

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites www.da.caraga.gov.ph and www.philgeps.net last November 21, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Drugs and Biologics under the Livestock Program;

WHEREAS, an opening of bids was conducted last December 10, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Pacifica Agrivet Supplies, Inc. and P&J Agricultural Trading, Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Pacifica Agrivet Supplies, Inc.'s bid offer is considered the Lowest Calculated Bid for Lots 1,2,3,5,6 and 7 while P&J Agricultural Trading, Inc.'s bid offer is considered the Lowest Calculated Bid for Lot 4;

WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that Pacifica Agrivet Supplies, Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid for Lots 1,2,3,5,6 and 7 while P&J Agricultural Trading, Inc., is considered the Lowest Calculated and Responsive Bid for Lot 4;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Drugs and Biologics for Lots 1,2,3,5,6 and 7 to Pacifica Agrivet Supplies Inc. and P&J Agricultural, Trading Inc., for Lot 4, as their bids were considered the Lowest Calculated and Responsive Bid;




