WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement on the Supply and Delivery of 3 units Recirculating Dryer (mobile) under the Corn Program;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that All Certified Equipment Trading Corporation passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, All Certified Equipment Trading Corporation's bid is considered the Single Calculated Bid;


