**A RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF
TRANSPLANTER (WALK-BEHIND TYPE) (A7)**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid (Accelerated Bidding) in the websites www.da.caraga.gov.ph and www.philgeps.net last November 16, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Supply and Delivery of 5 units Transplanter (Walk Behind Type) under the Rice Program;

WHEREAS, an opening of bids was conducted last December 09, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation namely, Ford Tractor Philippines and D' Brothers International Trading Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, Ford Tractor Philippines bid is considered the Lowest Calculated Bid but was declared disqualified due to alterations on the Bid Form;

WHEREAS, D' Brothers International Trading Corporation having the second Lowest Calculated Bid was considered for post-qualification;


WHEREAS, upon post qualification and deliberation conducted by the BAC members, it was found that D' Brothers International Trading Corporation was the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Supply and Delivery of 5 units Transplanter (Walk Behind type) to D' Brothers International Trading Corporation, as its bid is considered the Lowest Calculated and Responsive Bid.


