**A RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF  
VARIOUS VEGETABLE SEEDS (B11)**

Resolution No. 17-2020  
Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last January 30, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of Various Vegetable Seeds grouped into 2 Lots under the High Value Commercial Development Program;

Lot 1 = Lowland Vegetable Seeds  
Lot 2 = Upland Vegetable Seeds

WHEREAS, an opening of bids was conducted last February 20, 2020 at the DA Conference Room as scheduled;

WHEREAS, there were six (6) bidders that responded to the invitation namely, Seedworks, Allied Botanical Corporation, Pacifica Agrivet Supplies, Jeels Masagana Farm Supply, Ramgo International Corporation and J-777 Agri Marketing Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, the following were the findings;

- Lot 1 - Seedworks' bid having the Lowest Calculated Bid was disqualified due modification of Omnibus Sworn Statement, hence, Allied Botanical Corporation, being the next lowest calculated bid was considered and was found to have complied with the technical requirements.
- Lot 2 - Ramgo International Corporation's bid is considered the Lowest Calculated Bid and was found to have complied with the technical requirements.

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions;

WHEREAS, the BAC, however, determined the bidders' satisfactory previous performance with the agency in addition to the verification and authentication of submitted documents;

WHEREAS, upon further deliberation conducted by the BAC members, it was found that Allied Botanical Corporation is considered the Lowest Calculated and Responsive Bid for Lot 1, while Ramgo International Corporation is considered the Lowest Calculated and Responsive Bid for Lot 2;







