



A RESOLUTION RECOMMENDING THE AWARD FOR THE PROCUREMENT OF FEEDS (B18)
Resolution No. 24-2020
Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of Feeds (B18) under the SAAD Program grouped into 2 lots;

- Lot 1 - 856 bags various chicken feeds
- Lot 2 - 508 bags various swine feeds

WHEREAS, an opening of bids was conducted last February 20, 2020 at the DA Conference Room as scheduled;

WHEREAS, there was only One (1) bidder that responded to the invitation namely: Pacifica Agrivet Supplies;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that Pacifica Agrivet Supplies passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, Pacifica Agrivet Supplies' bid is considered a Single Calculated Bid for Lots 1 and 2;

WHEREAS, due to the occurrence of African Swine Fever (ASF) that hit some of the areas in the country including Mindanao, thus the procurement of the project under Lot 2, 508 bags of various swine feeds is cancelled;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions;

WHEREAS, the BAC, however, determined the bidders' satisfactory previous performance with the agency in addition to the verification and authentication of submitted documents;

WHEREAS, upon final deliberation conducted by the BAC members, it was found that Pacifica Agrivet Supplies is considered the Single Calculated and Responsive Bid for Lot 1;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award to Pacifica Agrivet Supplies the Procurement on the Supply and Delivery of 856 bags of various Chicken Feeds for Lot 1 as its bid is considered a Single Calculated and Responsive Bid.
