**A RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF
921 BAGS HYBRID CORN SEEDS (WHITE) (B2)**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Supply and Delivery of 921 bags Hybrid Corn Seeds (White) under the Corn Program;

WHEREAS, an opening of bids was conducted last February 20, 2020 at the DA Conference Room as scheduled;

WHEREAS, there were five (5) bidders that responded to the invitation namely, Fareast Agricultural MPC, Miracle Hybrid Corn Seed, Roy Agribest, Pacifica Agrivet Supplies and OJM Seed Producer;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, Fareast Agricultural MPC's bid is considered the Lowest Calculated Bid;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions;

WHEREAS, the BAC, however, determined the bidders' satisfactory previous performance with the agency in addition to the verification and authentication of submitted documents;

WHEREAS, upon deliberation conducted by the BAC members, it was found that Fareast Agricultural MPC is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 921 bags Hybrid Corn Seeds (white) to Fareast Agricultural MPC as its bid is considered the Lowest Calculated and Responsive Bid.
