**RESOLUTION RECOMMENDING THE AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF
GOAT HOUSE WITH PERIMETER FENCE (B32)**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 30, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the labor and materials for the Construction of Goat House with Perimeter Fence under the SAAD Program grouped into 3 lots;

- Lot 1 - Goat House at Bislig City, SDS - 2 units
- Lot 2 - Goat House at Lingig, SDS - 2 units
- Lot 3 - Goat House at Bayabas, SDS - 2 units

WHEREAS, an opening of bids was conducted last February 20, 2020 at the DA Conference Room as scheduled;

WHEREAS, there were only three (3) bidders that responded to the invitation namely, MAIR Construction & General Merchandise, BN Builders & Construction Supplies and ZEART Construction & Supply Co.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, MAIR Construction and General Merchandise's bid was considered the Lowest Calculated Bid on Lots 1, 2 & 3;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions;

WHEREAS, the BAC, however, determined the bidders' satisfactory previous performance with the agency in addition to the verification and authentication of submitted documents;

WHEREAS, upon further deliberation conducted by the BAC members, MAIR Construction and General Merchandise has complied with all the post qualification requirements, hence considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteaugudo to award the labor and materials for the construction of 6 units Goat House with Perimeter Fence to MAIR Construction and General Merchandise for having the Lowest Calculated and Responsive Bid.
