RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF INBRED RICE SEEDS (CERTIFIED) (C1)
Resolution No. 41-2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last May 12, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement on the Supply and Delivery of Inbred Rice Seeds (Certified) under the Rice Program:

WHEREAS, an opening of bids was conducted last June 1, 2020 at the DA Conference Room as scheduled;

WHEREAS, there was only (1) bidder that responded to the invitation namely, Bayugan Seeds Center.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that Bayugan Seeds Center passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, Bayugan Seeds Center's bid was considered a Single Calculated Bid;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions;

WHEREAS, the BAC, however, determined the bidders' satisfactory previous performance with the agency in addition to the verification and authentication of submitted documents;

WHEREAS, upon final deliberation conducted by the BAC members, it was found that Bayugan Seeds Center passed the Post Qualification requirements and was considered the Single Calculated and Responsive Bid;


