



**RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF ABACA AND CACAO PLANTING MATERIALS (C3)**

Resolution No. 63-2020  
 Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last May 12, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement on the Supply and Delivery of Abaca and Cacao Planting Materials under the SAAD Program which is grouped into lots:

- Lot 1 - 39,248 pcs Abaca Planting Materials
- Lot 2 - 21,875 pcs Cacao Planting Materials

WHEREAS, an opening of bids was conducted last June 1, 2020 at the DA Conference Room as scheduled;

WHEREAS, there were four (4) bidders that responded to the invitation namely, MLLJ Agri Trading, St. Padre Pios Garden, Lumad sa Agdawan Farmers Multi-Purpose Cooperative (LAMPUFACO) and Cayona Talento Nursery & Agri Supply;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that MLLJ Agri Trading was disqualified due to lack of Bid Securing Declaration while the 3 bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, the following were the findings:

- Lot 1 - LAMPUFACO's bid was the Lowest Calculated Bid however it was disqualified upon Post Qua due to insufficient stock availability and, St. Padre Pios Garden's bid being the next lowest calculated bid was also disqualified upon post qua due to non-compliance as to specification.
- Lot 2 - St. Padre Pios Garden's bid being the Lowest Calculated Bid was found to have complied with the technical requirements.

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions;

WHEREAS, the BAC, however, determined the bidders' satisfactory previous performance with the agency in addition to the verification and authentication of submitted documents;

WHEREAS, upon final deliberation conducted by the BAC members, it was found that St. Padre Pios passed the Post Qualification requirements and was considered the Lowest Calculated and Responsive Bid for Lot 2;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the procurement on the supply and delivery of Lot 2 - Cacao Planting Materials to St. Padre Pios Garden as their bid was considered the Lowest Calculated and Responsive Bid.

FURTHER, the BAC recommends that Lot 1 (Abaca Planting Materials) be procured thru small value procurement.
