**RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF 2,500 BAGS INBRED RICE SEEDS (D2)**  
Resolution No. 67-2020  
Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last July 24, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of 2,500 bags Inbred Rice Seeds with an ABC of P3,800,000.00 under the Rice Program:

WHEREAS, an opening of bids was conducted last August 18, 2020 at the DA Conference Room as scheduled;

WHEREAS, there was only one (1) bidder that responded to the invitation namely, Bayugan Seeds Center;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, said bidder was rated passed as to the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, Bayugan Seeds Center's bid was considered a Single Calculated Bid;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of said bidder with the Single Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions, thus a virtual post qualification was conducted last September 3, 2020;

WHEREAS, the BAC, also determined the bidders' satisfactory previous performance with the agency in addition to the virtual verification and authentication of submitted documents;

WHEREAS, upon final deliberation conducted by the BAC members, it was decided that Bayugan Seeds Center passed the Post Qualification requirements and was considered the Single Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 2,500 bags Inbred Rice Seeds (Certified) to Bayugan Seeds Center as their bid was considered the Single Calculated and Responsive Bid.




