RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF VARIOUS LIVESTOCK AND POULTRY (D3)

Resolution No. 62-2020
Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 24, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of various animals under the Livestock Program which are grouped into lots with corresponding ABCs as follows:

Lot 1 - 30 heads Cattle (Heifer)	P1,500,000.00
Lot 2 - 200 heads Upgraded Swine (Gilt)	P2,200,000.00
Lot 3 - 1,620 heads Chicken (Ready to Lay Pullets and 180 heads Cockerel)	P900,000.00

WHEREAS, an opening of bids was conducted last August 18, 2020 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation namely, Xynara Therese Nursery, Tommy's Hogs and Cattle and BMA Livestock Dealer;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, all said bidders were rated passed as to the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, Tommy's Hogs and Cattles' bid was considered the Lowest Calculated Bid for Lots 1 and 2 only and it is noted that there was no bid on Lot3 for all the said bidders;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions, thus a virtual post qualification conducted last September 3, 2020;

WHEREAS, the BAC, also determined the bidders' satisfactory previous performance with the agency in addition to the online verification and authentication of submitted documents;

WHEREAS, upon final deliberation conducted by the BAC members, it was decided that Tommy's Hogs and Cattle passed the Post Qualification requirements for Lot 1 and 2 and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of various 30 heads Cattle (Heifer) - Lot 1 and 200 heads Upgraded Swine (Gilt) - Lot 2 to Tommy's Hogs and Cattles as their bid was considered the Lowest Calculated and Responsive Bid.

FURTHER, the BAC recommends that Lot 3 (1,620 heads Chicken and 180 heads Cockerel) to be procured thru small value procurement.
