RESOLUTION RECOMMENDING THE AWARD FOR THE SUPPLY AND DELIVERY OF 22,259 BAGS UREA (D6)
Resolution No. 10-200
Series of 2020

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 24, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of 22,259 bags Urea with an ABC of 22,259,000.00 under the Rice Program:

WHEREAS, an opening of bids was conducted last August 18, 2020 at the DA Conference Room as scheduled;

WHEREAS, there were only two (2) bidders that responded to the invitation namely, Modern Time Enterprises, Inc. and J-777Agri Marketing Corporation;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, all said bidders were rated passed as to the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, **Modern Time Enterprises, Inc.'s bid** was considered the Lowest Calculated Bid;

WHEREAS, the BAC decided to forego the actual visit to conduct post qualification of bidders with the Lowest Calculated Bid due to the Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the Corona Virus Disease (COVID-19) which prescribed travel restrictions, thus, a virtual post qualification was conducted last September 3, 2020

WHEREAS, the BAC, also determined the bidders' satisfactory previous performance with the agency in addition to the online verification and authentication of submitted documents;

WHEREAS, upon final deliberation conducted by the BAC members, it was decided that Modern Time Enterprises, Inc. passed the Post Qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 22,259 bags Urea to Modern Time Enterprises, Inc. as their bid was considered the Lowest Calculated and Responsive Bid.




