

## COMPONENT 4: PROJECT MANAGEMENT

### SCOPE OF INTERVENTIONS:

- Support the significant planning, coordination, implementation, and logistics needed to ensure appropriate levels of engagement with the ADs' indigenous tribal councils and indigenous peoples organizations.
- It would also support the incremental staffing requirements at regional, and local levels that will be needed to implement the project effectively and undertake the needed data for the efficient implementation and progress monitoring.

### WHAT ARE THE REQUIREMENTS?

#### Eligibility criteria of ICCs/IPOs to participate the Project:

1. Holders of Certificates of Ancestral Domain Title (CADTs), Certificate of Ancestral Land Title (CALT) and Certificate of Ancestral Domain Claims (CADC);
2. Have Ancestral Domain Sustainable Development and Protection Plans (ADSDPPs);
3. Have at least one organized Indigenous People's Organization (IPO) recognized by the NCIP;  
For NCIP-recognized IPOs, must also need to be registered with any of the following:
  - a. Cooperative Development Authority (CDA)
  - b. Securities and Exchange Commission (SEC)
  - c. Department of Labor and Employment (DOLE)
4. Have a strong LGU support and ADSDPP are integrated to LGU Development Plan
5. The areas for production support with ADs should exclude:
  - a. Armed conflicts
  - b. Protected and forest areas

### WHAT ARE THE SUPPORT WE NEED?

- Crafting/Completion/Updating of ADSDPP in the target areas.
- Integration of ADSDPP to the LGU Development Plan.
- Strong support from partner LGUs.
- Creation of Regional Technical Working Group (RTWG) as per Joint Special Order No. 01 series of 2020 for DA and NCIP.
- Active participation of partner agencies during the implementation of the project.

## WHAT ARE THE BENEFITS?

### COMPONENT 1: SOCIAL PREPARATION

#### SCOPE OF INTERVENTIONS:

- ICCS/IP Needs Assessment
- Validation of ADSDPP/ prioritization of identified agri-fishery related projects
- Organization/re-organization of IPOs and accreditation/ registration to concerned partner agency/ies
- Registration of IP Farmers to RSBSA
- Registration of IP Farmers to PCIC
- Capability Building/conduct of trainings

### COMPONENT 2: PRODUCTION AND LIVELIHOOD ASSISTANCE

#### SCOPE OF INTERVENTIONS:

- Provision of production support services such as good quality seeds, organic & inorganic fertilizers, pre-and-post harvest equipment, tools and machineries and breeder animals where management arrangements will be coordinated with the ICC/IP communities for food security and poverty alleviation
- Improved access of technology thru the conduct of technology demonstration projects as a show window of technology thru “learning by doing and to-see is to-believe approach” for easy adoption of technology.
- Establishment of animal multiplier farms as a source of readily available breeder stocks for animal production and reproduction and also as a source of livelihood in the IP community.

### COMPONENT 3: MARKETING ASSISTANCE AND ENTERPRISE DEVELOPMENT

#### SCOPE OF INTERVENTIONS:

- Technical assistance & conduct of financial literacy training and facilitated access to finance, markets, services and public-private partnerships inside and outside the ADs (small brother-big brother approach)
- Market matching/linkage and farm consolidation approach
- Value-adding/processing of farm products

# WHAT IS 4Ks?

#### SPECIFIC OBJECTIVES

- To capacitate the ICCs/IPs through community organizing, technical skills trainings and workshops to increase knowledge and productivity;
- To provide various agri-fisheries assistance like agri-inputs, tools, machineries/equipment and facilities for production, post-harvest, processing and packaging to improve the economic condition of the ICCs/IPs in the country;
- To increase the number of ICCs/IPs farmers and fisher folk with access to Department of Agriculture assets and services;
- To improve the income of the ICCs/IPs through culturally responsive and environmentally sustainable income-generating livelihood activities.

#### BENEFICIARIES

The project shall cater to IP farmers and fisherfolks of recognized Indigenous Political Structure (IPS) by National Commission on Indigenous Peoples (NCIP) who have or are processing their Certificate of Ancestral Domain Title (CADT), Certificate of Ancestral Land Title (CALT) and Certificate of Ancestral Domain Claims (CADC).

#### SELECTION-CRITERIA OF FARMER-BENEFICIARIES

- Recognized members of Indigenous Political Structure (IPS) by the National Commission on Indigenous Peoples (NCIP);
- Indigenous Cultural Communities/ Indigenous Peoples with Certificate of Ancestral Domain Title (CADT), Certificate of Ancestral Land Title (CALT) and Certificate of Ancestral Domain Claims (CADC) holders;

Kabuhayan at Kaunlaran ng Kababayang Katutubo or 4Ks is a project inspired by the vision of **President Rody Duterte** to finally uplift the **Indigenous People** of the country from poverty by developing their **Ancestral Domain** through productive endeavors.

#### PROGRAM DESCRIPTION

4Ks is a three-year special project of the Department of Agriculture (DA) which followed the directives of the President.

It provides assistance to the ICCs/IPs in the form of agricultural and fishery related livelihood opportunities, investments, and various support services through targeted Community Needs Assessments (CNA).

This Project will provide capacity building to the ICCs/IPs, and will link them to credit facilities and crop insurance. Moreover, it is composed of four (4) Components such as, Social Preparation, Production and Livelihood, Marketing Assistance and Enterprise Development/Product Development, and Project Management.

#### PROJECT OBJECTIVE

##### GENERAL OBJECTIVE

Kabuhayan at Kaunlaran ng Kababayang Katutubo (4Ks) Project aims to develop the Ancestral Domains of the ICCs/IPs in order to improve its productivity by developing sustainable agricultural enterprises and profitability by increasing their income in consideration with their customs, traditions, values, beliefs, and interests.
